Checking Accounts

Checking Account Maintenance Fee (per month) for more than 4 accounts as described below	\$5
- You may have up to two Money Manager and two Quick Cash accounts at no charge.	
- Free unlimited checking accounts with eStatements and eNotices.	
Copies of Paid Checks	\$2 per copy
- Two copies per statement are free.	
- You may obtain copies of paid checks from the last 12 months within online banking for free.	
Stop Payment Fee (per check or Automated Clearing House [ACH] or online bill pay payment)	\$25
